

6263/6264 TRACK-IT™

INSTALLATION INSTRUCTIONS

TOOLS NEEDED:

7/16" Wrench 9/16" Wrench Adjustable Open End Wrench Pliers or Vice-Grips®

PARTS LIST:

- (2) Track-It™ Boat Trailer/Boat Guides
- (2) Wire Splice Connectors Model 6263 Only
- (6) Cable Wire Ties Model 6263 Only

Insert one of the 3/8 x 41/2" cap screws through the lone hole of the clamp plate, and then through the lone (or lower) hole of the aluminum guide bracket. Install, loosely, a lock washer and nut on the cap screw. Next, position these parts around the trailer axle with the aluminum guide bracket toward the rear of the trailer and the steel clamp plate toward the front. Insert the other cap screw, lock washer, and nut, using the most appropriate hole. Tighten lightly.


Position the $Track-It^{TM}$ guide just outside of the innermost bunk rail (see diagram) and finish tightening the nuts. **Do not over tighten.** Avoid pinching any electrical wires, brake lines or cables with the clamp assembly as you position the $Track-It^{TM}$.

Make any necessary vertical adjustments to allow the plastic guide rod to clear the crossmem-

ber of the trailer. Remember too, that some boat hulls have configurations which include tracking ridges or grooves which may project an inch or more below the main surface of the hull as it rests on the top of the bunk. The installer should make certain the unit is adjusted vertically to allow for clearance below such projections. Finish tightening the assembly.

For Model 6263, uncoil the single wire attached to the guide assembly and clamp (with enclosed **wire connector**) the end of the wire into the nearest "hot" wire of the trailer's tail light system. Secure the wire to the trailer's frame or axle (with the enclosed **plastic ties**) to keep it in place and free of snags.

To install the second guide on the opposite side of the trailer, repeat the above procedures.

Dutton-Lainson Company expressly disclaims any implied warranty of merchantability or fitness for particular purpose after the ninety (90) day warranty period. Some states do not allow the exclusion of incidental or consequential damages or limitation of an implied warranty, so the above exclusion and limitation may not apply to you.

To make a claim, contact Dutton-Lainson Company, Hastings, Nebraska 68902-0729, identify the product and date of purchase, and follow the instructions for return, which will be provided. Repair or replacement of the product, if found to be defective, will normally be completed within sixty (60) days after receipt. The purchaser will be responsible for shipping costs to the Company.

This warranty gives you specific legal rights, and you may have other rights which vary from state-to-state.
